

# Gorge Local Currency Cooperative (GLCC) Membership Application

The GLCC publishes a trade directory containing a list of advertisers, their goods and services for sale, requests for goods or services and display advertisements. The directory is updated and published quarterly. Your GLCC membership pays for four listings in four issues (one year) of the trade directory. All new members receive three RiverHOURS (RH) to begin spending in the community. Renewing members receive one RiverHOUR.

One year's advertising in the GLCC Trade Directory is \$42, half of which may be paid in RH. If this is a financial burden for you, contact us for information about our credit program to help get you started. Contact the GLCC for additional information about current pricing and availability of display advertising in the trade directory.

The Supporter category gives those who don't wish to have listings a chance to help support the GLCC. Supporters donate at least \$20 to the GLCC. As a Supporter, you will have no listings and receive no RiverHOURS, but be thanked in a separate list within the trade directory. You will also have one vote in member meetings. The Supporter category can be made tax deductible with these two easy steps:

1. Make your check out to the Columbia Gorge Earth Center.
2. Write RiverHOURS or GLCC on the memo line to be sure the amount is credited to us.  
The GLCC has a fund administration agreement with the CGEC, allowing us under their 501(c)3 umbrella.
